I've had meetings this meet with staff members of the Northern Virginia congressional delegation, including Senators Warner and Kaine. My aim is to convince them to draft and send a joint letter to Governor McAuliffe urging the governor to extend the CFV program on 66 past 1/1/17.

During my meetings, a couple of staffers have asked to hear from some of their constituents on the issue -- not negative in any way. More of a request for "cover" with their bosses to show that folks "back home" genuinely care about this issue (and its not just some guy named Greg bellyaching about it!).
